



# Application for Reservation of the LLA Clubhouse

Upon renting the LLA clubhouse facility, you must agree to the following conditions and policies:

1. The Lake Lenape clubhouse may only be rented by a member in good standing of Lake Lenape.
2. Alcohol is only permitted within the clubhouse, on the patio and in the immediate clubhouse vicinity. No alcoholic beverages are allowed on the beach at any time.
3. I assume full responsibility and will not allow alcohol to be available or served to anyone under 21 years of age.
4. I am responsible for returning the facility back to a clean and organized state which includes the following:
  - a. All trash must be bagged and placed in the dumpster. (Recycling must be separated)
  - b. No beverages or food are to be left in the refrigerator
  - c. All dishes and utensils used are to be cleaned and put away
  - d. The clubhouse floor must be swept and all chairs and tables put away
5. Lake Association supplies stored inside the clubhouse (such as food and beverages) and the BBQ grill are not to be used.
6. I assume full responsibility for any damage to Lake Lenape Association property that may occur while I am using the facilities.
7. I understand that the facilities are inspected prior to, and after my rental. My deposit check will be returned after the facilities are proven to be in good order and no other costs have been incurred.
8. I will abide by all State and Local laws, Association rules, regulations and policies currently in effect.
9. Live Bands or excessively loud music **are not permitted**. Facility curfew is 9:30 pm.
10. No glass containers are permitted on the Lake grounds at any time.
11. All facilities are to be used at your own risk.
12. Rental tents are permitted but rental coordinator must be consulted so that tents will not interfere with any scheduled lake function or other rental. Tent rental companies must be insured.
13. I understand that the use of the Lake (including swimming, boating and fishing) could be subject to restrictions or closure at any time due to State regulations or water quality.
14. During normal operating hours, the renter must provide a Lake Lenape certified lifeguard for the first group of twelve (12) swimmers and thereafter, every group of Twenty (20) additional swimmers. Lifeguard contacts will can provided upon request. The renter is responsible for paying the lifeguards at the rate of \$10 per hour per each additional lifeguard.
15. The clubhouse telephone is for emergency use ONLY. Any calls made will be charged to the renter.
16. The bathrooms and all public lake facilities must be made available to lake members at all times.
17. Checks that the bank returns will incur a \$30 service fee (per returned check).
