Boat Registration

All vessels afloat on Lake Lenape or stored on LLA property must display a current boat registration decal. Vessels that will be stored in designated LLA property locations must display the "On-Site Storage" decal. All others must display the "Off Site - Day Use" decal.

Please Note: On-Premise boat storage are subject to review every year. The storage inventory changes as new members join, existing members move away, and boats change ownership. If you are requesting On-Site boat storage, please list your requirements below to assist us in accommodating your needs. Storage facilities closest to the lake will be reserved for individuals with oversized vessels and/or special circumstances as a courtesy. Storage is at the vessel owners risk. The LLA cannot be held responsible for damage or theft of any vessel stored on LLA property. Decals should be applied no later than Memorial Day. Vessels not displaying a decal will be removed from the premises.
